Dear Sirs,

- (1) We have been appointed as Scrutinizer by the Company for conducting the postal ballot and e-voting process in a fair and transparent manner in terms of the resolution of Board of Directors of the Company dated 11th February 2015.
- (2) The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to e-voting and postal ballot on the resolution contained in the Notice of the postal ballot and e-voting dated the 27th day of May, 2015. Our responsibility as a scrutinizer for the voting process through electronic means and postal ballots is restricted to make a Scrutinizer's Report of the votes cast "in favour" or "against" the resolutions, based on the reports generated from the e-voting system of Central Depository Services (India) Limited (CDSL) and of voting received through postal ballots as provided by M/s C. B. Management Services Private Limited, Kolkata the agencies engaged by the Company to provide e-voting / postal ballot facilities.
- (3) We submit our report as under :
 - (a) The Company has completed the dispatch of physical postal ballot forms (containing e-voting instructions) along with postage prepaid self-addressed envelope and postal ballot (containing e-voting instructions) via electronic mode by 29th day of May, 2015 to its Members whose name(s) appeared on the Register of Members / list of beneficiaries as on the 22nd day of May, 2015.
 - (b) Particulars of all the postal ballot forms received from the Members have been entered in a register separately maintained for the purpose.
 - (c) The postal ballot forms were kept under our safe custody in sealed and tamper proof ballot boxes.
 - (d) The ballot boxes were opened after 6 p.m. on Tuesday, 30th day of June, 2015, in our presence.

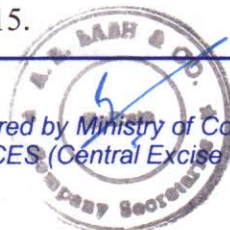




- (e) The postal ballot forms were duly opened in our presence and scrutinized.
- (f) All postal ballot forms received on or before 6 p.m. on Tuesday, 30th day of June, 2015, the last date as fixed by the Company for receipt of the forms, were considered for our scrutiny.
- (g) Envelopes containing postal ballot forms received after 6 p.m. on Tuesday, 30th day of June, 2015, *if any*, were not considered for our scrutiny.
- (h) We did not find any defaced ballot paper.
- (i) Summary of the Postal Ballot votes casted through Physical Mode is as follows :-

- (j) Members were provided the opportunity to cast their vote(s) through electronic voting system in terms of the platform as provided by CDSL e-voting system (www.evotingindia.com).
- (k) The e-voting period remained open from 9:00 A.M. IST on Monday, the 1st day of June, 2015 up to 6:00 P.M. IST on Tuesday, the 30th day of June, 2015.
- (l) The Shareholders holding shares as on the "cut off" date, i.e. 22nd day of May, 2015 were entitled to vote on the proposed resolution as mentioned in the notice of the postal ballot and e-voting dated 27th day of May, 2015.





(m) The result of the electronic voting was downloaded after 6 p.m. on Tuesday, 30th day of June, 2015 from CDSL website providing the platform for e-voting system (www.evotingindia.com) and were unblocked in the presence of Mr. Narayan Chandra Saha and Mr. Raju Chowdhury (not being the employees of the Company) and has been included in our report.
